Please note: all students must wear solid enclosed footwear for the duration of the course. Suitable identification must also be sighted.

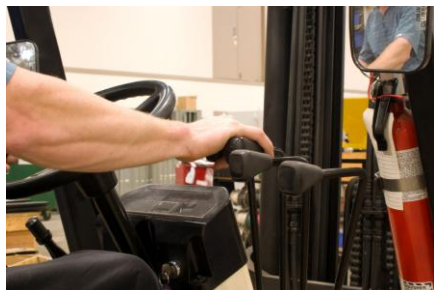
Please ask about State Government funded programs, which may be available dependant on eligibility and funding availability.

Forklift Training & Licensing

30496QLD Course in Operating Load-Shifting Equipment OHSCER207A Operate a Forklift Truck

Blueprint Employment and Training Inc offer this forklift training course through *30496QLD Course in Operating Load Shifting Equipment (OHSCER207A Operate a Forklift Truck)* at our training centres in Slacks Creek and Darra.

This **Blueprint Full Delivery Forklift Course** is targeted towards those students who have no or little prior experience or training in forklift operations. Typically these students may include (but are not limited to)

1. Employees who require/desire a forklift license but are unable to undertake formal structured training at their employers premises; or
2. People returning to the workforce either by individual enrolment or via sponsorship by a employment agency

The program is scheduled over 5 days (Monday to Friday) and includes self-paced study (approximately 12 hours); 2 days face-to-face formal instruction and 3 full days of practical driving experience under supervision. Once this experience has been gained trainees will sit the Challenge Assessment (Licencing Assessment). Note trainees must be 18 years or over to undertake a licensing assessment.

**The total cost of the program is of \$650.00¹ per person.

1) Enrolment and Course commencement

- a) Payment of \$650.00 at time of commencement (non-refundable)
- b) All training materials provided
 - i) Forklift Workplace Health & Safety Manual
 - ii) Forklift Operations Theory Manual
 - iii) Individualised Informal Learning Record (Log Book)

2) Training and Operational Experience

- a) Small groups guaranteed
- b) Trainees are required to gain operating experience between training and undertaking the licensing assessment. This operational experience is undertaken at our Warehouse Driver Centre's under supervision. Students will be required to undertake a number of driving tasks and demonstrate operational skills across a range of forklifts.
- c) Once minimum operational standards have been met students will undertake the formal licencing assessment.

3) Assessment and Licensing

- a) Assessments are usually undertaken at Blueprint Employment & Training Inc on the final day of the course (unless otherwise negotiated).
- b) Students **MUST** be 18 years of age or over
- c) The Challenge Test (Licencing Assessment) includes a written assessment (97 short answer questions) and a practical assessment component.
- d) After successful completion of the assessment applicants will be issued with:
 - i) An application form and information on license lodgment
 - ii) Copy of the assessment summary
 - iii) Statement of Attainment
