### Course Overview

### Course Duration, Delivery and Location

This program is delivered over 2 days at our convenient location in Underwood, and we can customise training to suit your individual or company's requirements. If you have a large group of staff to put through our forklift course and do not wish to lose them all at once, you can organise to put your staff through the course one at a time over a period of a few weeks, thus minimising the effect on your workplace production. Alternatively, onsite training and assessment may be more suitable.

- A State Government Licence fee of \$88.40 is applicable to be paid on licence lodgement at [www.worksafe.qld.gov.au](http://www.worksafe.qld.gov.au)
- Licence applications must be lodged within 60 days of successfully completing the practical assessment
- RPL (recognition of prior learning) may be available to those trainees who can demonstrate prior experience; knowledge and/or training. RPL applicants must undertake the formal Licensing Assessment and meet all legislative requirements
- Following an unsuccessful assessment result a re-assessment fee of \$100 may apply

### Course Cost

\$400 / person (no GST is applicable). A deposit of \$50 is payable on enrolment (non-refundable), and balance payable on first day of attendance.

*State Government funded programs in warehousing and logistics may be available depend on eligibility.*

### Entry Requirements

- Be able to read and write basic English
- Minimum 18 years of age to obtain High Risk Work (HRW) Licence
- Provide three forms of approved identification
- Students must wear solid enclosed footwear for the duration of the course.

After successful completion of the assessment applicants will be issued with:

- Copy of the Notice of Satisfactory Assessment (NSA)
- Information on the Application process
- Statement of Attainment – TLILIC2001A Licence to operate a forklift truck
